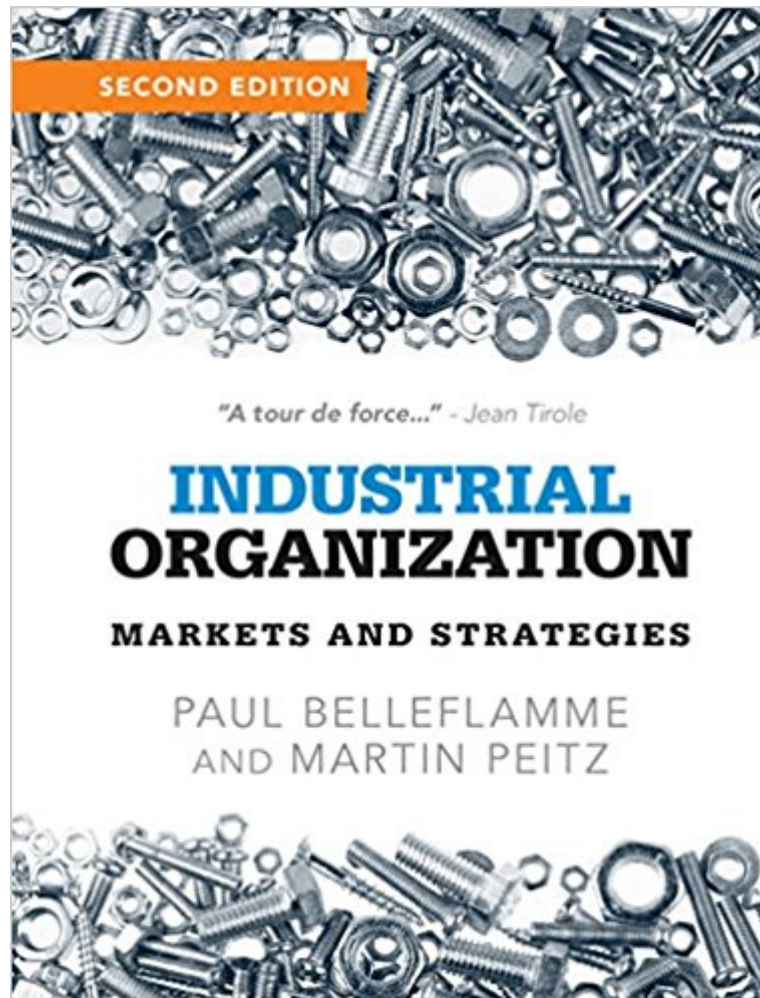

The thematic coverage is wide, covering theoretical models and some empirical research as well, and the exposition is quite balanced between text and math.
