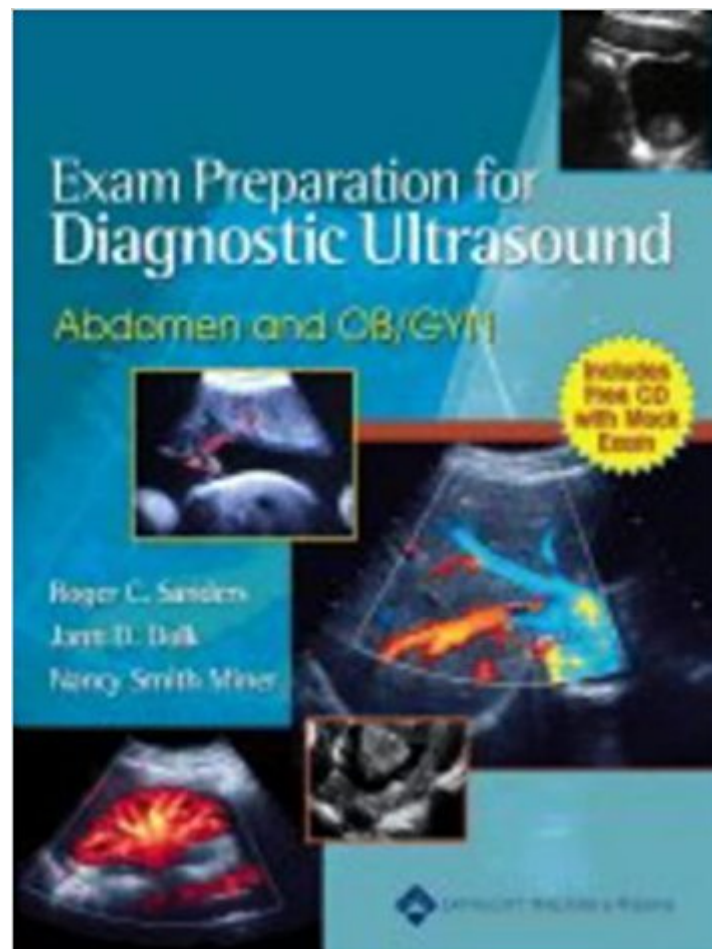

I used this book to test myself prior to taking the ABD exam. I absolutely did terrible scoring a 67% on the 412 questions. I passed the ABD with a 597. How?I memorized the ABD ESP book end to end. Supplemented by the review section in this book and the book my school provided to me to expand knowledge. I also used Davies mock exam (scoring about 80% average).My opinion on this book is that it is a great tool to expand your knowledge. You need to know your stuff to do well on

the questions on this book. I have limited clinical experience (being fresh out of school) which translated to me not depicting the sonograms well. The questions in this book are harder than the actual test. This book did not contain as many "easy" questions. This book provokes thought process which is essential in succeeding as a sonographer.

The images used for the practice exams are horrible!!!! But considering that's what you get on the RDMS, I guess it's a good preparation. The review section is VERY basic. I did like how the answers to the practice exams also gave a little explanation and it broke everything down so you could see where you are weak in.

I used it only for the AB exam (passed the OB prior), and found the 400+ questions similar in style and difficulty to those on the actual exam. It should be noted that the aid is more a test prep tool than a review of material -- use your class notes or some other prep book for review. I believe that if I had used this to prepare for the OB exam, I'd have had an easier time of it.

I recently bought this book before taking the Abdomen exam. I passed with a high score without a problem. I found the review questions to be really helpful, you have just over 400 questions to help you practice. I actually felt that some of the questions in this book were harder than the ARDMS questions I had on my exam. I thought it was a really good investment of my money.

This book is an excellent resource for those reviewing the abdominal ultrasound subject for the exam. Also it gives great hints on how to answer the multiple choice answers, which are sometimes so tricky. I recommend it to all candidates out there.
