

Though he struggled in vain for his client and his cause, Atticus Finch fought to make the jury system work because he knew that the independent jury is fundamental to our freedoms. Perdue's stories remind us why. *I Remember Atticus* is more than a collection of inspiring stories. It is also an indispensable resource for the trial lawyer seeking more effective persuasion techniques. Perdue gives generously of his wealth of trial experience to show how novices and veterans alike may use our core values for practical advocacy. And he does so in a way that entertains, informs, and inspires.
